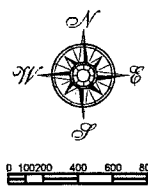

PLEASE OBEY OHV LAWS - MINIMUM \$200.00 FINE

- *Headlamp and tail lamp must be on while riding city streets.
- *NO exhaust modifications over 96 dB, violations strictly enforced. *Children under the age of 18 must wear helmet.
- *Children ages 8-11 cannot operate an ATV on any route.
- *TRAVEL ON HWY 8 OR HWY 25 PROHIBITED AND STRICTLY ENFORCED.
- *OFF ROUTE TRAVEL: City residents may operate to and from the ATV route closest to their residence.
- *DO NOT operate left of center on corners, use caution and reduce your speed on narrow trails outside the City.

Barron County is currently part of the UTV pilot program, properly registered UTV's are allowed on ATV trails/routes. No motorcycles/dirt bikes allowed on trails.
