The meeting was called to order at 6:00 p.m. by Mayor David Vruwink.

Aaron Marcoux, candidate for Barron County District Attorney appeared and introduced himself and gave a brief background on himself.

Amy Beckendorf appeared to discuss the Barron Area School District program called "Be Golden". Amy is a second grade elementary teacher at Woodland School.

Appearance by members of the public to discuss the fact that the ATV trail is closed near our municipal airport. Andrew Harrington, City Attorney explained why the City of Barron closed the trail back in late May, 2016. It was based upon a letter from the state dated April 21, 2016 which indicated the trail was breaking state law by crossing the airport. It was agreed to pursue another route as soon as possible. The police committee will try and determine another route and a special city council meeting could be called to approve said route.

ORDINANCE NO. 2016 - # 3 AN ORDINANCE TO AMEND TITLE 14 OF THE MUNICIPAL CODE OF THE CITY OF BARRON

The Common Council of the City of Barron do ordain as follows:

SECTION I. Section 14.22(b) Election: the term is amended to read as follows:

The Municipal Judge shall be elected at large at the spring election on the evennumbered years for a term of four years commencing on May 1 succeeding the years.

SECTION 11. This Ordinance shall take effect the day after passage and publication as provide by law.

Motion carried 6 ayes 0 nayes.

It was noted that quotes/bids are being accepted until June 17, 2016 for the removal of the existing cart sheds at the golf course. Liability insurance is required.

Moved by Allen, seconded by Tollman to approve the recommendation of the Police Committee regarding the quote from Andrew Prytz on materials and labor for the agility equipment, as follows: materials - \$2,360.00; labor-\$2,100.00; delivery and set-up-\$500.00 for a total of \$4,960.00. Motion carried 6 ayes, 0 nayes.

Discussion followed on the fact that as of July 1, 2016 the city will have one available Class B retail license for the sale of fermented malt beverages and intoxicating liquor. This is because Jerome Carle did not file his license for renewal for the period July 1, 2016 – June 30, 2017.
