Barron Chamber Tractor Ride

WAIVER AND RELEASE OF LIABILITY

In consideration of being permitted to participate in Barron Chamber of Commerce's Tractor Ride and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, I hereby agree as follows:

1. I acknowledge, agree and represent that I understand the nature of the activity and that I am qualified, in good health and in proper physical condition to participate in such activity. I agree to follow all rules of highway safety. I further acknowledge that the activity will be conducted over public roads and facilities open to the public during the activity and upon which hazards of traveling are to be expected.

2. I understand the act of traveling on a public road involves known and unknown risks of injury to me and other people and damage to real and personal property, which include but are not limited to death, permanent or temporary paralysis, disability, illness or disease, physical or mental damage and/or other injury, as well as damage to my equipment and personal property.

3. I specifically waive and release Barron Chamber of Commerce from any and all liability, claims, demands, losses, or damages of any nature whatsoever for any loss of property, personal injury and/or death arising from said event, including, but not limited to, the negligence of Barron Chamber of Commerce Inc. their successors, assigns, affiliates, subsidiaries, agents and employees, and/or volunteers (each one considered one of the "Releasees"). I further agree that if, despite this Waiver and Release of Liability (hereinafter "Release") I, or anyone acting on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or costs which any may incur as the result of such claim. I understand that this Release means I am giving up, among other things, the right to sue Barron Chamber of Commerce, their successors, assigns, affiliates, subsidiaries, agents and/or employees for injuries, including death, damages or losses I may incur. I further agree this Release shall bind my heirs, executors, administrators and assigns, as well as myself.
