Cautionary Statement to Owners Obtaining Building Permits

101.65(lr) of the Wisconsin Statutes requires municipalities that enforce the Uniform Dwelling Code to provide an owner who applies for a building permit with a statement advising the owner that:

If the owner hires a contractor to perform work under the building permit and the contractor is not bonded or insured as required under s.101.654(2)(a), the following consequences might occur:

- (a) The owner may be held liable for any bodily injury to or death of others or for any damage to the property of others that arises out of the work performed under the building permit or that is caused by any negligence by the contractor that occurs in connection with the work performed under the building permit.
- (b) The owner may not be able to collect from the contractor damages for any loss sustained by the owner because of a violation by the contractor of the one and two family dwelling code or an ordinance enacted under sub. (1)(a), because of any bodily injury to or death of others or damage to the property of others that arises out of the work performed under the building permit or because of any bodily injury to or death of others or damage to the property of others that is caused by any negligence by the contractor that occurs in connection with the work performed under the building permit.

## City of Barron Building Permit Fee Schedule

### Building Code Permits:

Fees for permits pursuant to this Section shall be based on the physical value of the work to be done. This value will be based on current costs of construction as determined by the Building Inspector.

<b>Administrative Fee</b>	\$20 (\$5 for Re-Roofing and Residing.)
<b>New One &amp; Two Family Homes</b>	\$450.00 + \$.20 per square foot (square foot total is based on all finished space, unfinished space and attached structures that are part of the submitted plan such as an attached garage, deck or porch).
<b>Residential Additions</b>	\$200.00 + \$.20 per square foot (square foot total is based on all finished space, unfinished space and attached structures that are part of the submitted plan such as an attached garage, deck or porch). Any addition over 800 square feet shall follow new home fees.
<b>Residential Alterations</b>	\$50 + \$7.00 per \$1,000.00, or fraction thereof, of cost (Building cost per RS Means costs).
<b>Manufactured Homes</b>	Permanent Foundation - \$500 + \$.10 square foot; Placed upon a slab, piers, or non - permanent foundation - \$400.00.
<b>Commercial &amp; Industrial New</b>	\$600.00 + \$.20 per square foot on the first 10,000 square feet of space and \$.10 per square foot on any remaining finished space, all unfinished space, and all attached structures that are part of the submitted plan such as an attached garage, deck or porch.
<b>Commercial &amp; Industrial Additions</b>	\$400.00 + \$.20 per square foot on the first 10,000 square feet of space and \$.10 per square foot on any remaining finished space, all unfinished space, and all attached structures that are part of the submitted plan such as an attached garage, deck or porch.
<b>Commercial &amp; Industrial Alterations</b>	\$100 + \$7.00 per \$1,000.00, or fraction thereof, of cost (Building cost per RS Means) up to \$500,000 and \$4 per \$1000.00 over \$500,000.
<b>Footing &amp; Foundation Permit</b>	\$100.00 Flat Fee
<b>WI State Seal</b>	\$35.00
<b>Plan Review</b>	10% of permit cost
<b>Erosion Control</b>	\$100 for projects disturbing more than 1,000 square feet of land and all new one and two family dwellings.

<b>Renewal Fee</b>	Half the original permit fee (minimum \$50.00; maximum \$250.00).
<b>Starting without permit</b>	Permit fee is doubled.
<b>Sheds up to 300 sq. ft.</b>	\$50.00
<b>Sheds/Detached Garages Pole Buildings 300+ sq ft</b>	\$100.00 + \$.10 per square foot + \$50.00 per electrical, plumbing, and HVAC.
<b>Decks</b>	\$100.00
<b>Porches &amp; Gazebos</b>	\$100.00
<b>Pools that require building permit</b>	\$180.00
<b>Sign</b>	\$50.00
<b>Fence</b>	\$50.00
<b>Fireplaces</b>	\$100.00
<b>Electrical/Gas Service Inspection</b>	\$100.00 if not part of another permit.
<b>Repairs</b>	See Additions & Alterations above.
<b>Re-Inspection Fee</b>	\$100 for re-inspection over two inspection trips.
<b>Other Inspections</b>	\$50.00 per hour
<b>Move or Raze</b>	\$100.00
<b>Re-Roofing &amp; Residing</b>	\$25
